## AMEA Professional Member – PM

### Application requirements and conditions for new members are:

Eligibility for membership in the Association of Equipment Appraisers as an AMEA Professional Member (AMEA – PM) is open to individuals and firms whose work interrelates with that of professional appraisers. This category includes, but is not limited to, attorneys, accountants, insurers and bank and trust officials. AMEA Professional Members have an interest in the appraisal profession, but do not prepare appraisals or represent themselves as appraisal practitioners. This category is only for those individuals and firms whose primary business does not involve the buying, selling, or appraising of capital equipment.

### Application requirements and conditions for new members are:

- Provide a description of the type of business services that are provided.
- Have been in business for at least three (3) years.
- Participate in an interview with the Association of Machinery and Equipment Appraisers Membership Committee representative.
- Applicant must attest that they:
  - Have not been expelled from the Association of Machinery and Equipment Appraisers.
  - Have not been expelled from the Machinery Dealers National Association.
  - Are not currently associated with a firm whose membership was rejected, terminated, or expelled by the Machinery Dealers National Association.
  - Will use the AMEA Professional Member logo during their tenure of membership in the manner prescribed by the Association (AMEA).
  - Submit a completed application with two (2) sponsors who are members of the Association of Machinery and Equipment Appraisers.

### Requirements and conditions for designation retention are:

• AMEA Professional Members must remain at all times in good standing with the Association of Machinery and Equipment Appraisers.

All payments must be in U.S. funds, payable to AMEA. New member dues will be billed upon completion of the application process and prorated based on the AMEA membership year. The Application process must be completed within 24 months and any fees collected are not refundable.
